

**RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

IN CONSIDERATION for being permitted to participate in the Norwood Park Wine Stroll, sponsored by the Norwood Park Chamber of Commerce.

THE UNDERSIGNED PARTICIPANT:

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE The Norwood Park Chamber of Commerce or any other sponsors and all of its holdings, and owners and leases of premises used to conduct the event and each of them, the management, officials and volunteers assisting in the event, the sanctioning organization or any subdivision thereof, promoters, sponsors, advertisers; all for the purpose herein referred to as "release s", from all liability to the undersigned, their personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by negligence of the releases or otherwise while the undersigned is participating in the event;
2. AGREES that he or she will not use or operate any vehicle in violation or contravention of any City, County, State or Federal laws, statures, ordinances or regulation and shall be personally liable for all fines and penalties for traffic law violations.
3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to negligence of releases or otherwise while participating in the event.
4. AGREES that the participating businesses hold the right to deny wine to overly intoxicated participants, for the safety of both their property and others.

THE UNDERSIGNED expressly acknowledges and agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by law of the State in which it is operated in and if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agree that no oral representations, statements or inducements apart from the foregoing written agreement have been made.
